2024 at a Glance: Sharing the Impact of Your Generous Giving

Formation Counseling Services (FCS) was part of the grand opening of the Compassion Center on the campus of Crosspoint City Church (CPCC) in Cartersville, Georgia, on Monday, February 26, 2024. The Compassion Center, a ministry of CPCC, provides services and resources for those challenged by homelessness, those being rescued from sex trafficking, and those struggling with illiteracy. FCS has been offered ten offices to conduct our ministry out of the Compassion Center in partnership with CPCC. With tremendous gratitude to God and CPCC, we look forward to the impact FCS will have through those ten offices.

FCS continues to establish and serve ministry partnerships with churches to address the unmet need for mental health services, which is at a crisis level in the communities we serve in New Mexico and Georgia. Each partnership helps FCS expand the reach of its services without having to pay for bricks-and-mortar or rent. In 2024, your generosity supported 10 FCS ministry locations in New Mexico and 5 in Georgia. FCS employs 38 counselors and 6 additional staff.

FCS provides an enormous volume of clinical services each year, including 22,383 hours of counseling in 2024. We currently have 1,243 active clinical situations under our care. Imagine the impact your giving is having when so many lives are experiencing healing, growth, and renewal, and then those lives are positively impacting their families, churches, and communities. We are grateful for the impact of the services we provide while we pray for resources to expand our ministry to meet the great need for services that is currently beyond our capacity.

One of the most dramatic aspects of your giving is that we continue to host healing conversations for those with the fewest resources and the greatest need-people who ordinarily would have no access to counseling services. This is particularly meaningful for our ministry because we believe this is what Jesus would have us do.

Another way to describe the impact of your giving is that you support a \$2 million ministry, with total revenue and expenses near \$2 million for 2024 and the four previous years.

Since the ministry began in November of 1984, FCS has had a strong commitment to train the next generation of Christian counselors. That commitment recently led FCS to provide internship opportunities for those completing a master's degree in counseling. We had two interns in 2024, and another is set to begin in 2025. Your giving supports the development of these counselors, which helps address the tremendous need for counseling in our communities.

You see from the above that your gifts to FCS represent a powerful way to love your neighbor.
